1. FUNDAMENTALS OF LAND SURVEYING EXAMINATION — Graduation from a board approved program of four (4) years or more in land surveying from a college or university.
2. FUNDAMENTALS OF LAND SURVEYING EXAMINATION — Graduation from a program of four (4) years or more other than land surveying from a college or university of recognized standing plus completion of a twenty-four (24) semester credit hour core curriculum in land surveying.
3. FUNDAMENTALS OF LAND SURVEYING EXAMINATION — Graduation from a civil, mining, or agricultural engineering program of four (4) years or more accredited by the Engineering Accreditation Committee of the Accreditation Board for Engineering and Technology plus completion of a twelve (12) semester credit hour core curriculum in land surveying.
4. FUNDAMENTALS OF LAND SURVEYING EXAMINATION — Until June 30, 2011, graduation from a four (4) year program other than land surveying accredited by one of the Commissions of the Accreditation Board for Engineering and Technology plus two (2) years of land surveying experience following graduation from the program.
5. FUNDAMENTALS OF LAND SURVEYING EXAMINATION — Until June 30, 2011, graduation from a two (2) year board-approved program in land surveying plus two (2) years of land surveying experience.
6. FUNDAMENTALS OF LAND SURVEYING EXAMINATION — Until June 30, 2011, graduation from high school or equivalent followed by the completion of four (4) years of land surveying experience.
7. PRINCIPLES & PRACTICE OF LAND SURVEYING EXAMINATION — Achieve a passing score on the Fundamentals of Land Surveying Examination and meet the eligibility requirements as stated in (1) above and not less than three (3) years of experience.
8. PRINCIPLES & PRACTICE OF LAND SURVEYING EXAMINATION — Achieve a passing score on the Fundamentals of Land Surveying Examination and meet the eligibility requirements as stated in (2) or (3) above and not less than four (4) years of experience.
9. PRINCIPLES & PRACTICE OF LAND SURVEYING EXAMINATION — Achieve a passing score on the Fundamentals of Land Surveying Examination and meet the eligibility requirements as stated in (4) or (5) above and not less than six (6) years of experience.
10. PRINCIPLES & PRACTICE OF LAND SURVEYING EXAMINATION — Achieve a passing score on the Fundamentals of Land Surveying Examination and meet the eligibility requirements as stated in (6) above and not less than ten (10) years of experience.
