4	201 KAR 18:192. Continuing professional development for professional land surveyors
5	RELATES TO: KRS 322.180(3), 322.190, [322.270,]322.290(15)
6	STATUTORY AUTHORITY: KRS 322.290(4), (15)
7	NECESSITY, FUNCTION, AND CONFORMITY: KRS 322.290(15) requires the board
8	to adopt a program of continuing education for professional land surveyors. This administrative
9	regulation establishes requirements for [implements] the continuing professional development
10	program mandated by KRS 322.290(15) for professional land surveyors.
11	Section 1. Definitions.
12	(1) "Calendar year" means a one-year period of time beginning on January 1 and ending
13	on December 31.["Completion" means the professional land surveyor has satisfactorily met
14	specific requirements of an offering by taking and passing a university course or attending a
15	seminar.]
16	(2) "Contact hour" means a minimum of 50 minutes of instruction or presentation.
17	(3)[(2)] "Continuing professional development" or "CPD" means participation in
18	activities, beyond the basic educational requirements, that:
19	(a) Provide specific content planned and evaluated to improve the professional land
20	surveyor's [professional-]competence;
21	(b) Encourage acquisition of new skills and knowledge required to maintain competence:

1	(c) Strengthen the professional land surveyor's critical inquiry and balanced judgment;
2	(d) Raise the ethical standards within the professional community; and
3	(e) Meet the requirements established by this administrative regulation.
4	(4) "Dual Licensee" means a person licensed as both a professional land surveyor and a
5	professional engineer.
6	(5)[(3)] "Licensee" means a person licensed as a professional land surveyor.["CPDC"
7	means the Continuing Professional Development Committee.]
8	(6)[(4)] "Professional development hour" or "PDH" means one (1) nominal contact
9	hour[not less than fifty (50) minutes] of instruction or presentation that meets the requirements of
10	this administrative regulation.
11	(7)[(5)] "Provider" means a person, school, association, company, corporation, or group
12	who has developed a CPD activity and participates directly in the presentation.
13	(8)[(6)] "Reporting period" means the two (2) calendar years preceding the June 30
14	deadline for renewal of license.["Sponsor" means a group, organization, or professional society,
15	offering activities by providers.]
16	(9) "Surveying Committee" means the Surveying Committee of the State Board of
17	Licensure for Professional Engineers and Land Surveyors.
18	[Section 2. Continuing Professional Development Committee. (1) The chair of the State
19	Board of Licensure for Professional Engineers and Land Surveyors shall appoint a Continuing
20	Professional Development Committee and name its chair.
21	(2) The CPDC shall consist of five (5) board of licensure members of which at least three
22	(3) are professional land surveyors.

1	(3) Work of the CPDC shall be considered work of the board, and compensation shall be
2	given as provided by KRS 322.270.
3	(4) The CPDC shall hold regular meetings, and a record of its action shall be maintained.
4	(5) The CPDC may rule on all matters concerning continuing professional development
5	for professional land surveyors.
6	(a) In order to be binding, a decision of the CPDC shall be ratified by the board.
7	(b) A licensee who disagrees with a decision of the CPDC may direct his or her concerns
8	to the board for consideration at a subsequent meeting of the board.]
9	Section 2[3]. Program Structure.
10	(1) Except as provided $\underline{in}[by]$ Section $\underline{5}[6(1) \text{ and } (2)]$ of this administrative regulation[
11	and subsection (3) of this section], a licensee[professional land surveyor] shall complete [and
12	report to the board a minimum of eight (8) professional development hours for each calendar
13	year, for a total of]a minimum of sixteen (16) PDH units[professional development hours for]
14	each reporting period.
15	(2) The requirement for <u>continuing</u> professional development [hours-]shall include a four
16	(4) PDH[hour] course, pre-approved by the <u>Surveying Committee</u> [CPDC], in standards of
17	practice for professional land surveyors, professional ethics, and the code of professional practice
18	and conduct, taken once every four (4) years. This[In the year that this] course [is taken, it-]shall
19	count as four (4) of the required sixteen (16) PDH for the reporting period in which it is
20	taken[eight (8) hours].
21	(3) If a licensee exceeds the requirement, a[A] maximum of eight (8) PDH units[four (4)
22	hours in excess of the sixteen (16) professional development hours required to be earned in a
23	reporting period] may be carried forward to the next reporting period.

1	(4) PDH units earned by a dual licensee under this administrative regulation may also be
2	used to meet the professional engineer requirements under 201 KAR 18:196 if the PDH units
3	also meet the requirements of 201 KAR 18:196.
4	(5)[(4)] Failure to earn the required PDH units[sixteen (16) professional development
5	hours per reporting period] shall constitute unprofessional conduct[make the licensee ineligible
6	for licensure renewal].
7	Section 3[Section 4]. Criteria for Professional Development.
8	(1) Continuing professional development activities applicable to the renewal of the
9	license shall be directly related to the professional growth and development of the professional
10	land surveyor.
11	(2) PDH units[(1) Professional development hours] may be earned upon[by] successful
12	completion of the following activities:
13	(a) College or university courses;
14	(b) Continuing education courses[Seminars];
15	(c) Short courses, tutorials, webinars, and distance-education courses offered as face-to-
16	face programs, live internet-based programs, archived prerecorded programs, or archived
17	correspondence programs[Tutorials];
18	(d) Presenting or attending qualifying seminars, in-house courses, workshops, or
19	professional or technical presentations made at meetings, conventions, conferences, or
20	educational institutions[In house programs sponsored by corporations or other organizations];
21	(e) [Correspondence courses;
22	(f) Televised or videotaped courses;
23	(g) Distance learning courses;

1	(h) Teaching or instructing <u>activities</u> [courses, programs, or items] specified in
2	paragraphs (a) through (d)[(g)] of this subsection;[-]
3	[1. This credit may be claimed at twice the number of hours permitted participants.
4	2. The credit shall not be claimed more than once for teaching or instructing the same or
5	substantially similar course, program, or item;
6	(i) Making or attending approved presentations at technical or professional meetings; or
7	(f)[(j)] Authoring published[Publication of] papers, articles, [or-]books, or accepted
8	licensing examination items related to the practice of land surveying; or[-]
9	(g) Active participation in professional or technical societies as authorized in subsection
10	(5)(g) of this section.
11	(3)[(2)] To qualify for credit, activities[Activities] described in subsections[subsection]
12	(1) and (2) of this section shall:
13	(a) Be relevant to the practice of land surveying;
14	(b) Contain technical, ethical, or managerial subjects;
15	(c) Be an organized program of learning;
16	(d) Be conducted by individuals with education, training, or expertise; and
17	[(e) Be offered for the number of professional development hours recommended by the
18	program author, subject to review and acceptance or adjustment by the CPDC; and
19	(e)[(f)] Not include:
20	1. In-service training;
21	2. Orientation to specific institutional policies and practices; or
22	3. Time used to sell or advertise a product; or[-]
23	4. Self-study.

1	(4)[(3)] CPD activities shall earn credit only if substantially different from a course for
2	which credit was claimed or granted in the current reporting period[ealendar year or previous
3	two (2) calendar years].
4	(5)[(4)] PDH units[Professional development hours] shall be converted as
5	follows:[established in paragraphs (a) through (c) of this subsection.]
6	(a) Credit for college or university courses shall be based upon course credit established
7	by the college or university.
8	1.[(a)] One (1) university semester hour shall equal forty-five (45) PDH units[fifteen (15)
9	professional development hours].
10	2.[(b)] One (1) university quarter hour shall equal thirty (30) PDH units[ten (10)
11	professional development hours].
12	(b)[(e)] One (1) continuing education unit shall equal ten (10) PDH units[professional
13	development hours].
14	(c) One (1) nominal contact hour of professional development in coursework, seminars,
15	or professional or technical presentations made at meetings, conventions, or conferences shall
16	equal one (1) PDH unit. The total number of hours allowed for an activity cannot exceed the
17	actual number of clock hours.
18	(d) Credit for correspondence, televised, videotaped, distance learning, and other short
19	courses or tutorials shall be the equivalent PDH units recommended by the program author
20	subject to board review.
21	(e) For teaching an activity described in paragraphs (a) through (d) of Section 3(2),
22	multiply the number of PDH units earned by participants for that activity by two (2). Teaching
23	credit shall only be valid for the first time the activity is taught.

1	(1) Each published paper, article, or book shall equal ten (10) PDH units.
2	(g) Active participation in a professional or technical society shall equal two (2) PDH
3	units for each organization.
4	1. Credit for active participation in professional or technical societies shall require that
5	the licensee serve as an officer or committee chair of the organization.
6	2. PDH units shall not be earned until the end of each year of service is completed.
7	Section 4. Recordkeeping. (1) The licensee shall be responsible for maintaining records
8	used to support PDH units claimed.
9	(2) Records required include:
10	(a) A log showing the date of the activity, provider, location, activity title, description,
11	presenter's name, and PDH units earned; and
12	(b) Attendance certification records in the form of completion certificates or other
13	documents supporting evidence of attendance.
14	[Section 5. Approval of a Continuing Professional Development Activity. Activity
15	approvals may be granted for sponsors, providers, or individual professional land surveyors.
16	(1) Approval of activities shall be valid for a specified approval period or until alteration
17	of the activity is approved by the CPDC.
18	(2) Failure to notify the CPDC of a change in an activity, including a change in the
19	instructor, may render approval of the activity null and void.
20	(3) Prior to approval, an activity shall not be advertised as approved for Kentucky
21	professional land surveyors but may be advertised that the activity has been "submitted for
22	consideration."

1	(4) If prior or post approval is desired, a written request for approval of the activity shall
2	be submitted to and received by the CPDC on the Continuing Professional Development Course
3	Approval Form at least forty-five (45) days prior to the meeting date of the CPDC at which the
4	request will be considered.
5	(5) All requests for approval of an activity shall be accompanied by:
6	(a) A detailed outline and objectives;
7	(b) A time outline including registration, introductions, welcomes, breaks, and meals;
8	(c) Handouts or reference materials needed to evaluate the activity; and
9	(d) A resume for each instructor or speaker in the activity.
10	(6) The CPDC or board may send a representative to monitor an activity.
11	(a) The provider or sponsor shall waive all fees for the CPDC or board representative.
12	(b) Approval for the activity may be withdrawn for subsequent iterations of the activity,
13	if significant variation is observed from the approved activity.
14	(7) An evaluation form shall be made available for participants at each presentation.
15	(8) An individual under disciplinary action from the board or a business entity with a
16	principal who is under disciplinary action from the board shall not present a CPD activity for
17	credit without prior, written approval from the board.
18	(9) If a provider fails to obtain prior approval, a professional land surveyor may request
19	credit for an activity by making a written request for post approval to the CPDC and including in
20	that request, the items listed in subsection (5) of this section.
21	(10) Upon approval, an activity shall receive a CPD number, which shall be used to
22	identify the activity.

1	(11) If an activity is not approved by the CPDC, the requestor shall be sent notice of
2	nonapproval within two (2) weeks of its decision. This decision shall be presented to the board at
3	its next meeting for consideration of ratification.]
4	Section 5[6]. Exemptions and Extensions. [A professional land surveyor may be
5	exempted from the requirements of this administrative regulation by submitting a written request
6	to the CPDC with supporting documentation for the exemption if a requirement established in
7	this section is met.]
8	(1) A <u>licensee[professional land surveyor]</u> shall be exempted <u>from continuing</u>
9	professional development requirements for the [reporting period containing the]calendar year in
10	which the licensee [he or she] is initially licensed by the board. If the licensee is initially licensed
11	in the first calendar year of the reporting period, the number of PDH units required for that
12	reporting period shall be eight (8) PDH units.
13	(2) A licensee who is on active duty in the Armed Forces of the United States shall be
14	exempted from continuing professional development requirements for those years in which the
15	licensee was on active duty.
16	(3) An individual who has selected inactive or retired status shall be exempted from
17	continuing professional development requirements.
18	(4)[(2)] A licensee[professional land surveyor] who is unable to[eannot] satisfy the CPD
19	requirement because of physical disability, illness, or other extenuating circumstance may be
20	granted an extension[exempted] for the calendar year in which the disability, illness, or
21	extenuating circumstance occurs.
22	(5) The board[CPDC] may grant an extension of time to fulfill the [yearly-]CPD
23	requirement for an extenuating circumstance.

1	(6)[(3)] An exemption or extension request shall be made in writing, with supporting
2	documentation, to the board during the calendar year in which the exemption or extension is
3	requested[for each calendar year], and the exemption or extension shall only be valid for that
4	calendar year.
5	Section <u>6</u> [7]. Reinstatement. Before a license is reinstated by the board under 201 KAR
6	18:115, a former licensee[professional land surveyor] shall earn the PDH units[continuing
7	professional development hours] required for each reporting period[year] the license was
8	revoked, suspended, [or-]expired, or in inactive or retired status up to a maximum of thirty-two
9	(32) PDH units[professional development hours].
10	Section 7[8]. Reporting. [(1)] A <u>licensee[professional land surveyor</u>] shall certify whether
11	or not the licensee[he or she] has complied with the requirements of this administrative
12	regulation during the biennial renewal of license on the Electronic License Renewal Application,
13	available at www.kyboels.ky.gov]. The failure to truthfully report compliance with this
14	administrative regulation shall constitute unprofessional conduct.
15	[(2) Biennial renewal forms received after September 1 shall be subject to the audit
16	process in Section 9 of this administrative regulation.]
17	Section 8[9]. Audits.
18	(1) Compliance with the [annual-]CPD requirements shall be determined through an audit
19	process.
20	(2) Four percent (4%) of licensees who have completed their biennial renewals before
21	September 1 of their renewal year shall be selected for audit through a random selection
22	process[Professional land surveyors shall be audited through a random selection process or as the
23	result of information provided to the board].

1	(3) All licensees who complete their biennial renewals on or after September 1 of their
2	renewal year shall be subjected to the audit process.
3	(4) A licensee who is the subject of an investigation pursuant to KRS 322.190 shall be
4	subjected to the audit process.
5	(5)[(3)] A licensee[Individuals] selected for audit shall provide the board with
6	documentation as described in Section 4 of this administrative regulation within thirty (30) days
7	of the board's request.[, provide the board with documentation of the CPD activities claimed for
8	the renewal period. Appropriate documentation shall include:
9	(a) Verification records in the form of transcripts, completion certificates, or other
10	documents supporting evidence of participation; or
11	(b) Information regarding seminar or course content, instructors, and sponsoring
12	organizations.
13	(4) Individual licensees shall maintain verification records and documentation for audit
14	purposes for the current reporting period and at least the two (2) previous reporting periods.]
15	(6)[(5)] If continuing professional development credit is disallowed, the licensee[a
16	professional land surveyor] shall have sixty (60)[180] calendar days after notification to
17	substantiate the original claim or earn other PDH units[eredit] to meet the requirement.
18	(7)[(6)] Failure to comply with the CPD requirements shall constitute[be considered] a
19	violation of KRS 322.180[(3)] subjecting the <u>licensee[professional land surveyor</u>] to disciplinary
20	action.
21	(8)[(7)] An audit resulting in a determination of noncompliance shall subject the
22	licensee[professional land surveyor] to an automatic audit for the next reporting period and each
23	subsequent reporting period until an audit results in a determination of compliance.

1	(8) A professional land surveyor who is under investigation pursuant to KRS 322.190
2	shall be subject to the audit requirements of this section.]
3	Section 9. Approval for a Standards of Practice, Professional Ethics, and Code of
4	Professional Practice and Conduct course.
5	(1) The Surveying Committee shall pre-approve instructors for a four (4) PDH course in
6	standards of practice for professional land surveyors, professional ethics, and the code of
7	professional practice and conduct.
8	(2) Approval of the course shall be valid for three years.
9	(3) Failure to notify the board of a change in the course, including a change in the
10	instructor, may render approval of the course null and void.
11 ,	(4) A written request for approval of the course shall be submitted to and received by the
12	board at least sixty (60) days prior to the meeting date of the Surveying Committee at which the
13	request will be considered.
14	(5) All requests for approval of the course shall be accompanied by:
15	(a) A detailed outline and objectives;
16	(b) A time outline including registration, introductions, welcomes, breaks, and meals;
17	(c) All presentation materials, handouts, and reference materials; and
18	(d) A resume for instructor.
19	(6) The board may send a representative to monitor live presentations of the course.
20	(a) The provider shall notify the board at least 60 (sixty) days prior to providing a live
21	presentation of the course.
22	(b) The provider shall waive all fees for the board representative and reimburse costs, if
23	any, of attending the course.

1	(c) Approval for the course may be withdrawn for subsequent iterations of the course if
2	significant variation is observed from the approved course.
3	(7) An evaluation form shall be made available for participants at each presentation.
4	(8) An individual under disciplinary action from the board or a business entity with a
5	principal who is under disciplinary action from the board shall not present the course without
6	prior, written approval from the board.
7	(9) Upon approval, an activity shall receive a CPD number, which shall be used to
8	identify the course.
9	(10) If a course is not approved by the Surveying Committee, the requestor shall be sent
10	notice of disapproval within two (2) weeks of its decision. This decision shall be presented to the
11	board at its next meeting for consideration of ratification.

- (1) Provide a brief summary of:
 - (a) What this administrative regulation does:

This administrative regulation establishes the continuing education requirements for professional land surveyors.

(b) The necessity of this administrative regulation:

KRS 322.290(15) requires the board to adopt a program of continuing education for professional land surveyors.

(c) How this administrative regulation conforms to the content of the authorizing statutes:

The regulation contains the details and requirements for mandated continuing education for professional land surveyors.

(d) How this administrative regulation currently assists or will assist in the effective administration of the statutes:

Professional land surveyors will understand continuing education requirements necessary for renewal of licensure.

- (2) If this is an amendment to an existing administrative regulation, provide a brief summary of:
 - (a) How the amendment will change this existing administrative regulation:

This amendment addresses the following main areas of refinement: removes the process for pre-approval of continuing professional development, with the exception of the required 4 professional development hour (PDH) course in standards of practice for professional land surveyors, ethics, and the code of professional practice and conduct; places responsibility for pre-approval of the 4 PDH required course with the Surveying Committee of the Board; eliminates the necessity of the Continuing Professional Development Committee, which will no longer be preapproving continuing professional development; simplifies language regarding the number of professional development units to be completed per reporting period; changes carryover from 4 professional development hours to 8 professional development hours per reporting period to be consistent with the original intent of the regulation; defines the number of professional land surveyors audited as 4% to be consistent with proposed changes to 201 KAR 18:196 (continuing professional education of professional engineers); decreases the number of professional land surveyors audited to 4% so as to streamline the audit process; helps streamline a professional land surveyor's ability to track continuing education in line with the requirements in other states; clarifies the reporting period for continuing education and defines calendar year; and makes changes to be more consistent with the continuing education program for professional engineers (201 KAR 18:196). Additionally, it makes some minor changes in wording to enhance clarity in other parts of the regulation.

(b) The necessity of the amendment to this administrative regulation:

This amendment is necessary to provide clarity to the requirements for continuing education compliance, to the audit process, to provide time and cost savings with regard to the process of approval of programs for continuing education requirements, and to assist professional land surveyors in tracking their continuing education requirement for Kentucky.

(c) How the amendment conforms to the content of the authorizing statutes:

The amendment conforms to KRS 322.290(15) since said statute requires a continuing education program for professional land surveyors.

(d) How the amendment will assist in the effective administration of the statutes:

This amendment enhances the clarity of the requirements of the professional development program and provides the supporting regulatory language for the board to enforce the requirement of KRS 322.290(15).

(3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation:

Licensed professional land surveyors and continuing professional development providers will be impacted by this regulation.

 - (a) List the actions that each of the regulated entities identified in question (3) will have to take to comply with this administrative regulation or amendment:

Professional land surveyors will need to ensure they familiarize themselves with the clarifying language to the regulation.

Continuing professional development providers will no longer be able to seek preapproval of continuing professional development courses, with the exception of the required 4 professional development hour course in the standards of practice for professional land surveyors, ethics, and the code of professional practice and conduct. The continuing professional development providers wishing to provide the standards of practice for professional land surveyors, ethics, and the code of professional practice and conduct will need to comply with the requirements for seeking approval with the Board's Surveying Committee.

(b) In complying with this administrative regulation or amendment, how much will it cost each of the entities identified in question (3):

There are no expected costs for those identified in question (3).

(c) As a result of compliance, what benefits will accrue to the entities identified in question (3):

Professional land surveyors will receive continuing education credit required for renewal, be allowed to carryover more professional education hours to the following reporting period, and guidance for completing continuing professional development credit for renewal will be clarified.
